A public hearing will be held by the Tax Supervising and Conservation Commission on the budget approved by the Budget Committee for Portland Public School District 1J, Multnomah County, Oregon for the fiscal year July 1, 2021 through June 30, 2022. The hearing will be held on Tuesday, June 15, 2021 at 4:30 PM. The purpose of the hearing is to discuss the budget with interested persons prior to adoption by the Board of Education. In light of current public health concerns related to COVID-19, under the provision of ORS 192.670 the virtual meeting will be conducted online, rather than in person.
